The Chandigarh Commission for Protection of Child Rights (CCPCR) has been constituted under section 17 of the Commission for Protection of Child Rights (CCPCR) Act, 2005 vide a notification issued by the Govt. of India, Ministry of Home Affairs vide Notification no. F.No.11030/1/2007-UTL dated 7th August, 2013 as a monitoring body on child rights.

It has come to our notice of the Chandigarh Commission for Protection of Child Rights (CCPCR) that Sh. Diljit Dosanjh is going to perform in the Live show scheduled for 14.12.2024 at Exhibition Ground, Sector-34, Chandigarh.

After going through the representation received by the Commission, the CCPCR has decided to issue the following advisory in best interest of the children: -

1. As per the World Health Organization's report that adults should not be exposed to sound with a peak sound pressure level above 140db. For children, the level is reduced to 120 db. It is advisable that not invite the children on stage during Live show where peak sound pressure level is above 120db which is harmful for children.
2. Avoid to perform the songs i.e. Patiala Peg, 5 Tara, Case etc. even with twisted words in which Alcohol, Drugs and Violence are promoted. These songs affect the children of impressionable age.
3. Kindly ensure below 25 years youngsters are not served Alcohol which is punishable under JJ Act and other provisions of law.

You are therefore requested to comply the advisory issued by this Commission's in the best interest of the children.
